Summary of Events

Burglary of a Motor Vehicle

Robbery

7300 Louetta Rd - Complainant gave suspect a ride to an unknown location at which time he felt threatened when the male asked for money. Complainant gave the suspect money and the suspect fled the scene.

7300 Louetta Rd - Suspect entered a business and told the clerk he had a weapon in his pocket. Suspect demanded money in which the complainant complied.

Criminal Mischief
